MINUTES OF THE COUNCIL MEETING HELD IN THE PARISH ROOM, STOWMARKET ROAD, ON WEDNESDAY 02nd SEPTEMBER 2015

01 Questions from the Public

A resident inquired about the bollards on Stowmarket Road not illuminated, Councillor Field agreed to contact SCC.

A resident inquired about the Neighbourhood Watch Scheme and who would represent it.

A resident inquired why the PCSO had been cancelled in the village, they were informed that the parish council had a vote and it was in favour of cancelling the level agreement, the resident informed the parish council that some residents wanted the PCSO back in the village, it was decided to add the possibility of re instating the PCSO Level Agreement on to October's Agenda for discussion.

A resident inquired about the pathways at the back and along side each allotment being kept clear. Was this the allotment holders or the parish council's responsibility. The information will be checked on and reported back at October's meeting. Also the resident mentioned the lock on the barrier had broken, the resident was informed that Councillor Scott had looked at the lock and it had been damaged.

A resident inquired about humps or 10mph signs to be possibility erected in Mill Lane, to slow down the traffic approaching the Village hall and play area. Councillor Field agreed to look into the matter and report back.

a. To discuss update on Building Plans with MSDC - It was decided to meet with Mr Isbell to discuss building plans, in early October as two of the Parish Councillors were on holiday the rest of September, but also to check with SALC that a meeting off site was acceptable.

- c. To Discuss Compensation from Barclays Bank The parish council agreed to contact the bank and ask for £25.00 compensation for the inconvenience of returning to the bank to sign forms.
- d. To discuss third party authority and forms for parish clerk It was agreed that the parish clerk could have third party authority on the bank account to order new cheque books, statements and paying in books only.
