Along with the bank on Bramford Road, this will be managed in September. This is a long-term project so will take some time to cultivate.

Concerns over the Port One new no right turn sign and vehicles – Advised that this issue has been reported to Highways and Cllr Chambers will following up for an update.

Has there been any update on the blocks placed on Blue Barn Lane? The issue has been reported to Highways and they have advised that they will investigate a more practical ideas to stop motorbikes accessing the lane and to allow access for pushchairs and wheelchairs.

Manhole cover outside Tollgate Farm is damaged so the noise from traffic driving over it especially HGV lorries is awful. Requires reporting to Highways.

## Flooding in Great Blakenham added to 22/23 Drainage Improvement Programme


I am pleased to confirm the continued flooding that effects properties up to 25 Gipping Road has been added to 2022/23 Drainage Improvement Programme.

Engineers with specialist equipment attended the effected area throughout April and early May to investigate the issue with the hope they could alleviate the problem. However as we had long suspected, the problem was far more serious.

Therefore Suffolk Highways have added this to the 2022/23 Drainage Improvement Programme and designs are currently underway with works expected to be carried out by the end of 2023 or early 2024.

This work will include raising both the kerbs and the footpath at the driveway to number 25 and repairing collapses to some pipes.

## Library services protected as Suffolk County Council approves additional funding

Suffolk County Council in May underlined its commitment to library services in Suffolk.

Suffolk County Council has underlined its commitment to library services in Suffolk, as it approved plans to increase its funding to Suffolk Libraries, to enable the service to continue operating at its current level, until the end of the contract in July 2024.

Suffolk Libraries currently receives £5.9m per year from Suffolk County Council, however the service is forecasting a deficit of £60k per month from April 2023. The service has cited increases in service costs, a reduction in income opportunities following the Coronavirus Pandemic and rising inflation, as causes of the deficit.

This means it is no longer possible for the service to continue operating at its current level of service, within its current contract value.

At Suffolk County Council's Cabinet meeting, the council has approved plans to absorb this cost pressure, funding Suffolk Libraries an additional £720k per year, through to the end of the current contract in July 2024. This additional funding will support Suffolk Libraries to continue delivering its highly valued services to Suffolk Residents.

# Suffolk residents urged to #ShakeltOut when recycling

A new campaign by Suffolk Waste Partnership is encouraging people to empty plastic bags and not throw them in recycling.

The #ShakeItOut campaign has been launched by the Suffolk Waste Partnership to encourage households in Suffolk to help improve recycling rates across the county by making sure black bin bags and other plastic sacks are not thrown in with recyclable materials.

#ShakeItOut is encouraging people to shake out plastic bags and keep recycling clean, dry, and loose.

The Partnership, which comprises Babergh District Council, East Suffolk Council, Ipswich Borough Council, Mid Suffolk District Council, Suffolk County Council, and West Suffolk Council, says more than a quarter (26%) of the materials in Suffolk's recycling bins in 2022/23 were not able to be processed as they were spoiled.

Items that contributed to spoiled recycling collections included:

- Materials that were not clean and dry, or contained food and drink residue
- Rubbish sacks or plastic bags containing recycling
- Non-recyclable items, such as nappies and food waste

Plastic bags and rubbish sacks are a particular problem - recycling handlers can't see what's inside them and they are often full of rubbish or other non-recyclable items.

This means bags are removed during the sorting process to avoid spoiling other good recycling. Any removed bags are then sent for disposal. Sign W N.to 13.7.23

## £10 million new funding to fix residential roads

Local road surfaces in villages and residential areas in Suffolk should be blitzed as part of a new £10 million programme, Suffolk County Council has announced today (25th May).

The extra funding will nearly double Suffolk Highways' £11 million annual roads maintenance budget, but be targeted at smaller residential streets which are typically maintained less frequently than busier A and B roads.

The announcement was made by Suffolk County Council's leader, Cllr Matthew Hicks, at the authority's annual general meeting.

The funding is subject to a formal Cabinet decision which will follow later this year.

### Commitment to Improving Key Services

Cllr Hicks reiterated the council's commitment to improving services for children with special educational needs and disabilities, including £55 million to create 1,275 new SEND school places by 2025.

Highways and SEND will be areas of particular focus for Suffolk County Council over the next two years. There was also reaffirmed commitments to deliver:

- The Gull Wing bridge in Lowestoft
- · New homes on SCC land
- Further help for Ukrainian refugees
- · A new highways contract with Milestone Group
- Hundreds more EV charging points
- A £20 million flood prevention and footpath improvement programme.

To coincide with the annual general meeting, Suffolk County Council has published a list of its top 50 achievements since 2021, including:

- Our Cassius Digital Care work and innovation is going from strength to strength
- An extra £2.5m for mental health services
- 300 miles of road now designated as quiet lanes
- New household waste sites in Ipswich and Haverhill
- £13 million in funding secured for active travel
- 3,000 environmentally friendly homes being delivered on SCC land
- 250,000 trees planted
- Over 100 new EV charging points
- A new Highways Contract with Milestone starting in October
- 43,400 streetlights converted to LED.

# Mid Suffolk's new leader outlines initial priorities

Mid Suffolk District Council's new leader has outlined the priorities for its new administration – refocusing the council's work in a "greener and more sustainable direction" whilst tackling community issues.

Cllr Andy Mellen was elected as the council's new leader at the Annual Council Meeting on 22<sup>nd</sup> May. Cllr Rachel Eburne was appointed his deputy, while the new chair of the council will be Cllr Rowland Warboys with Cllr Daniel Pratt as vice-chair.

The cabinet will be made up of six portfolios:

- Cllr Andy Mellen (leader) Performance and resilience
- Cllr Rachel Eburne (deputy leader) Finance and resources
- Cllr Andrew Stringer Heritage, planning and infrastructure
- Cllr Tim Weller Environment, culture and wellbeing
- · Cllr Richard Winch Housing and property
- Cllr Teresa Davis Thriving towns and rural communities

In his leader's speech, Cllr Mellen said the administration would re-focus the work of the council in a "greener and more sustainable direction".

He said the council would take the lead and work with others to address challenges faced by communities - such as the cost-of-living, finding an affordable place to live, provision of local services, town centre decline, public transport, and climate change.

Cllr Mellen said the administration wanted to improve the 'liveability' of communities - supporting the provision of key facilities.

"This might be the local pub which also hosts the village post office or the food bank, two examples that are already happening. It could be redundant farm buildings re-purposed as a micro-brewery or a professional services centre, or the village hall which acts as a hub for community life.

On the administration's approach to the climate emergency, Cllr Mellen said: "We must take environmental concerns into account in every decision that we make: how we work; what we invest in; the kind of houses we build, the locations we allow to develop, the type of businesses that we support and encourage, and all the services we provide."

# Gateway14: Latest plans submitted

Plans have been submitted for a new 164,500 sq ft manufacturing and warehouse unit at Gateway 14 – the new state-of-the-art business, innovation and logistics park taking shape in Stowmarket.

Property developer Jaynic, in partnership with Gateway 14 Ltd – a wholly owned subsidiary of Mid Suffolk District Council – has submitted a reserved matters planning application for the latest addition to the Freeport East site, adjacent to Junction 50 of the A14.

The new unit has been designed to include EV charging, LED lighting, solar PV, smart energy systems and rainwater harvesting, delivering low carbon and net zero solutions where possible.

Biodiversity is also a priority, with high-quality landscaping, green corridors and nesting boxes all being introduced to support not only the wildlife and ecology but also to create a vibrant, attractive, and healthy working environment for employees.

Gateway 14 Ltd and Mid Suffolk District Council also intend to bring forward a skills and innovation centre for the site, providing a dedicated space for start-ups and businesses looking at innovative ways to grow.

# Suffolk residents urged to #ShakeItOut and keep recycling clean, dry and loose

A campaign encouraging people in Suffolk to shake out their plastic bags and not to put them in their recycling bins is underway.

The #ShakeItOut campaign has been launched by the Suffolk Waste Partnership to encourage households in Suffolk to help improve recycling rates across the county by making sure black bin bags and other plastic sacks are not thrown in with recyclable materials.

The partnership, made up of the county, district and borough councils in Suffolk, says more than a quarter (26%) of the materials in Suffolk's recycling bins in 2022/23 were not able to be processed as they were spoiled.

Items that contributed to spoiled recycling collections included:

- Materials that were not clean and dry, or contained food and drink residue
- Rubbish sacks or plastic bags containing recycling

Rob Cole, of Suffolk Waste Partnership, said:

"We know from previous research that 73% of Suffolk residents are concerned about the environment and most people want to get their recycling right\*.

"Our Shake It Out campaign aims to help residents better understand their recycling services and ensure items are clean, dry and loose when they are placed in their recycling bins.

"We appreciate that some households may collect their recycling in plastic bags, to make it easy to carry out. This great work can be wasted if recycling is then added to your wheelie bin in a plastic bag.

"We're urging all Suffolk residents to make sure any plastic bags used to collect recycling are shaken out into the recycling bin."
